Thank you for your interest in Leadership Hernando! Since 1991, Leadership Hernando has sought to identify individuals most likely to utilize their leadership abilities for the long-term benefit of Hernando County. Over the past 33 years, the Greater Hernando County Chamber of Commerce has been presenting this program to the business community, graduating over 800 business professionals who have gone on to become remarkable Hernando County community leaders.

This leadership program was designed to explore critical issues through a series of seminars and hands-on activities. Our program includes topics such as: the history of Hernando County; leadership skills; tourism; agriculture; health and human services; law enforcement and First Responders; economic and business development; government; media, and more.

We are committed to creating new county knowledge. Our program Steering Committee is made up of Leadership Hernando Alumni who are armed with practical knowledge so we can continually advance the content of this program. This Steering Committee will determine the composition of each class assuring diversity from a variety of businesses, non-profits, educational institutions, government agencies, cultures, and functional backgrounds. Class-size is limited, and commitment to the program remains paramount.

Approximately twenty (20) individuals will be selected to participate in the program following an interview process by the Steering Committee. Since the number of appointments to Leadership Hernando is limited, applicants who are not selected are encouraged to reapply in a future year.

Leadership Hernando participants are selected based on the following criteria:

- ✓ Live or work in Hernando County.
- ✓ Have the full support of the organization, corporation, or company they represent.
- ✓ Have a sincere interest and are motivated to serve the community.
- ✓ Have the commitment and enthusiasm to utilize their leadership abilities for the long-term benefit of Hernando County.
- ✓ May be interested in seeking, or intend to seek, public office, boards, commissions, or key volunteer roles.
- ✓ Have potential opportunities for advancement to top leadership positions within their organizations.
- ✓ Represent all segments of the community.
- √ Have a commitment to play a personal role in helping to shape Hernando County's future.
- ✓ Have a professional appearance and demeanor.

The program strives for classes that represent the geographic, occupational, gender, ethnic, and other diversities of our area which includes public, not for profit, private, and large and small businesses.

The tuition paid for Leadership Hernando may be tax deductible as a business expense but consult your tax advisor. Tuition must be paid prior to Orientation, or you will not be allowed to attend.

\*If an additional (or different) official Leadership Hernando polo shirt or nametag needs to be ordered (due to loss, damage) it will be at the expense of the participant/participant's employer.

Partial scholarships may be available for *non-profit* organizations. Please submit a letter of need with this application.

### Commitment

Participants are expected to attend ALL sessions, each of which will last a full day (8 a.m. - 5 p.m.). To graduate, a participant must attend *Orientation*, Team Building, SIMSOC, and Graduation.

Advanced notification of a potential missed day, excluding emergencies, must be submitted to Day Leader(s) at least 24 hours prior to class.
